

FMC Mileage Reimbursement Rate

Effective Monday, July 1, the rate at which Fairfield Medical Center reimburses employees for mileage driven in personal vehicles for work related purposes will be 47.5¢ per mile. The reimbursement rate will be examined quarterly and will be set according to the following costs for gasoline based on the AAA state average:

\$2.51 - \$3.00 per gallon 45¢ per mile
 \$3.01 - \$3.50 per gallon 47.5¢ per mile
 \$3.51 - \$4.00 per gallon 50¢ per mile
 \$4.01 - \$4.50 per gallon 52.5¢ per mile

Employee Solutions Program

In last week's Monday Morning, the Message from Mina column included information about the current initiative to improve the hospital's bottom line by \$10 million. This will include many suggestions by all Fairfield Medical Center team members to reduce costs and increase revenues. Because those are the same goals as the Employee Solutions Program (E\$P), that program has been discontinued. Staff members are eligible for quarterly bonuses if FMC achieves both financial and patient satisfaction goals so everyone will benefit from these great suggestions.

HR Corner

PAY FOR PERFORMANCE:

In January, employees received a letter from Mina Ubbing announcing the 2013 Pay-for-Performance program. This program will not be directly tied to an individual employee's performance appraisal and base rate of pay. Beginning, July 2013, there will be two types of pay for performance for employees (excluding chiefs, directors and managers) and these are listed below:

- The first is the Key Contributor Award that will be awarded quarterly beginning July 2013 by Senior Leadership. This award is based on nominations from managers and supervisors. This program will define outstanding performance and its measurement across the entire organization. The chief officers will receive, support and present the nominations for review and will make the final decision on granting the award and the amount of award, from \$500 to \$2,500. Nomination forms are available on the Intranet under the Human Resources tab.
- The second is a Quarterly Incentive Program in which employees will receive an incentive award for achievement of financial and patient satisfaction goals. These goals are:
 - 1. Financial Performance:** Achievement of 1.6 percent total margins less investments
 - 2. Patient Satisfaction:** Weighted average of overall rating of care

These goals are based on a rolling six-month average of

performance. Both goals must be met for the incentive bonus to be paid. All full-time, part-time and contingent employees will receive the same lump sum amount. You have received monthly updates on our quarterly incentive program. The first six-month period for the incentive payment began on Jan. 1 and ends June 30. Performance for that period will be reported in July and the first award payment is eligible for payment in August. IF the financial and patient satisfaction performance remains the same as or improves over the May report, the incentive award will be paid. The success of this pay-for-performance program depends upon our working together, allowing us to focus our energy and efforts on two of the most critical goals we have and to give us the opportunity to recognize and reward individual performance that achieves outstanding outcomes.

Bedside Charges

A Six Sigma Bedside Charges team was convened after it was determined that there was not a standardized, accurate process for capturing and entering bedside procedures charges. Fairfield Medical Center wants to maximize reimbursement for charges and expenses we provide to our patients. This is so we can appreciate their cost of care as well as ensure favorable reimbursement and give our customers, our patients, confidence in our billing practices.

- Why is this project important? This project is important to the sustainability of our organization (potential additional revenue of \$498,120.19 yearly based upon baseline data).
- What is our problem? Baseline data from March 1-Sept. 1, 2012, found a 71.6 percent of accuracy of billed daily charges compared to services ordered. This impacts our ability to capture all of the expenses we provide to our patients so that we can appreciate the cost of their care as well as to ensure favorable reimbursements.
- What is our goal? Increase our accuracy of billed daily bedside charges and bedside procedures charges from 71.6 to 95 percent.

While working through the DMADV process, it was determined that McKesson had options for an electronic solution and the process has begun to define and implement

this solution. In the interim, the team has worked diligently to develop a method to bridge this gap temporarily. They are implementing a manual process to capture as many daily bedside charges as possible with a pilot scheduled to roll out on Third Med./Surg., ICU and PCU as it has been determined that these units have the most bedside procedures in the patient tower. The unit clerks on these units will be the "Champions" of this manual process and training for all nurses and unit clerks will begin June 18 in anticipation of the "go live" date for the pilot of July 1-30. The results of the pilot will be audited weekly by the team for accuracy.

After the pilot, the team will examine the success of the project and the method for adaptation for the rest of the patient tower.

doors, the patient required advanced life support including CPR and defibrillation. Dr. John Hazlip and Dr. Jeremy Buckley were awaiting EMS arrival. After continued resuscitation, the patient regained a pulse and was taken to the Cardiac Cath Lab suite for a heart catheterization. Immediately upon arrival to the Cath Lab suite, the patient lost a pulse and required numerous rounds of CPR, defibrillations and ACLS medications all occurring during the left heart cath procedure to open the artery. After almost 45 minutes of intermittent pulses, CPR, etc., the artery was opened and the patient regained a pulse with hypotensive blood pressure. The case was discussed with Dr. Doug Pope, Dr. Michael Falkenhain and Dr. Christian Tencza. Hypothermia protocols were initiated and the patient was admitted to the ICU. The ICU staff was well prepared for


with high marks. Please keep up the great work.

Healthy Hydration in the Summer Heat

Hydration is important all year long, especially during these hot summer months. The body is made up of 60-70 percent water and up to 11 cups can be lost a day. Replenishing your water supply is a vital part of staying healthy. Water regulates body temperature, flushes wastes out of the body and protects organs and tissues. During

these scorching hot summer months, it is important to remember to stay hydrated. Although the amount of water a person needs a day differs between individuals, the Institute of Medicine determined that an adequate intake for men is roughly 13 cups of total fluid a day and the adequate intake for women is about 9 cups each day. Active individuals need even more, particularly if they're exercising. You can meet your body's water needs over the course of a day through a variety of fluids and foods including smoothies, tea, soups, fruits and vegetables, and of course regular water.


