Message from Mina

Social media is all around us today. Whether we use it personally or not, we still can be affected by its contents. The purpose of this message is to ask those of you who Tweet or use Facebook, for example, to think about the possible unintended consequences of your posts or tweets. Please remember that these messages are not necessarily as private as you might think.



Recently, I have received several concerns about posts from members of our staff. One believes that the comments could violate HIPAA. Certainly the description depicted could help identify and might well embarrass a patient. Another resulted in a student not being invited back for an additional clinical rotation based on her profane and derogatory comments about her experience here. Another described how much one of our employees hated her job. The reaction from the reader of that one was that she would never come to FMC because of how poorly we treat our staff.

Everyone has the right to express themselves on social media. That's freedom of speech. However, I am not sure that all comments and photos are meant for those who eventually see them and can be hurt by them. Some of the venting that goes on is in the moment and you might intend it to be funny and those close to you might recognize that, but it can make an impression that you don't really want to make. Some employers check out Facebook and other social media outlets when considering a job candidate. It's really a small world. Who knows when or how something you have said can come back to cause you harm or embarrassment? Please keep that in mind. Thanks!

From the Chief's Desk

Over the past six months, I have been given a gift. I have experienced the healthcare industry through the eyes of a patient with a serious illness. Along my unexpected journey, I have received care in our Emergency Department, Observation Unit, Inpatient Unit, Infusion Clinic, Surgery, Radiology, Lab, Outpatient Cardiology and Outpatient Therapy areas. As I progressed through my journey, labs and radiology exams were ordered, tests and procedures were performed and medications were prescribed. Most of my experiences were positive, but I found it interesting that my experiences could differ widely from one area to another, even within the same facility. No matter who I was interacting with or in what area, communication stood out as one of the most influential factors. More importantly, the way a person listened and conveyed non-verbal body language was essential to my patient experience. What mattered the most to me, was genuine caring and kindness, especially when I was scared or hurting. I didn't always know the right questions to ask or how to advocate for myself (despite



being a physician). So those moments when someone reached out to me, spent an extra minute listening or made me feel like they weren't in a hurry, were the moments that made the difference. Thank you to everyone who makes that difference for our patients every day!

Donation from Aladdin Shriners

On Aug. 1, Fairfield Medical Center received a donation of \$47,697 from the Aladdin Shriners for the purchase of various pediatric equipment in the Emergency Department, Sports Medicine and Outpatient Therapy Services. Mr. Hank Kauffman, Jr., Tarhe Shrine Club President and Past Potentate of Aladdin Shriners, III, Sir D. Dee Mowry, presented the checks to President and CEO Mina Ubbing, Chief Nursing Officer Cynthia Pearsall, Development Officer Latricia Johnston, Registered Nurse Jennifer Mitchell and Outpatient Therapy Services Manager Carolyn Gilliam on behalf of FMC. "Fairfield Medical Center wishes to extend many heartfelt thanks to the Aladdin Shriner's for their recent gift," Johnston said. "This gift will be used to purchase an AccuVein handheld vein illumination device for pediatric patients in the Emergency Department and throughout the Center." Johnston also noted that triaging Emergency Department patients and preparing them for transport to Nationwide Children's Hospital when indicated, often requires the need of an IV. "In children and infants, finding an accessible vein can be very difficult and can add to the trauma." Approximately 47 percent of pediatric

patients require multiple sticks and the AccuVein can reduce this by up to 30 percent. Funds will also be used for an anti-gravity treadmill and numerous pediatric equipment for outpatient therapy and speech therapy patients. "All of the equipment will benefit children and adolescents with orthopedic, musculoskeletal and burn diagnoses," Gilliam said. "This equipment will assist with fine-motor and gross-motor coordination, balance, eye-hand coordination, sensory processing, strengthening and endurance, which are all necessary skills for continued development and growth. We are so very fortunate to have been chosen to receive such a kind gift." The Aladdin Shriners Hospital Association for Children (ASHAC) is located in Columbus, OH and is part of the Aladdin Shriners organization. ASHAC is designed to take care of children in Aladdin Land and the local clinic operates from Nationwide Children's Hospital. The program provides medical attention, evaluation and equipment at no cost to patients or families in need. "She has ensured that the message has gone out in FMC's organizational magazine called the Monitor that is sent to more than 60,000 households. This material has been utilized at health fairs in three counties as well as distributed to several physicians' offices from a variety of specialties. Rhonda goes above and beyond to help people know what to do with early heart attack care every day."

The average guessed amounts were from \$150 - \$5,000. Remember this was collected randomly for one week, by two housekeepers from two different units from three discharges or transfers. Let's take this one step further. One discharge at \$31 per patient experience

(averaging from the above collection process) x 365 days = potential financial loss to the organization of \$11,315, and this does not include the expense of disposing of wasted supplies! So, the next time you are taking supplies to the room, please determine what the patient needs are first. The format of the program has changed and the series can be completed in more than one way. Project BRIGHT Updates

Ground Breaking News:

The first shovel of dirt (or pound of pavement) will be moved to officially launch Project BRIGHT on Thursday, Sept. 12 at 2 p.m. in the parking lot to the south of the Human Resources entrance. The groundbreaking celebration will run from 1:30 - 3:30 p.m. and marks the beginning of FMC's 14-month facility expansion project. There will be refreshments served and displays with Project BRIGHT information. Video footage will be posted on the FMC Intranet and Internet so those who are unable to attend this historical event can virtually participate.

Last week:

Oncology Services moved to 214 Harmon Ave., which is located between the main hospital and Pavilion. Three spaces to the west side of the medical building have been dedicated to oncology patient parking. Additional spaces have been designated in the back of the building

as well. The relocation will be effective throughout Project BRIGHT, which is estimated to be 12-14 months. Radiation Oncology will remain in its current location.
