Mount Carmel Celebrates **SIXTH SDAP Class**

Congratulations to the sixth SDAP graduating class!

The Second Degree Accelerated Program (SDAP) celebrated its sixth SDAP Completion Ceremony on February 8, with 62 members of the 2012-13 class receiving nursing pins and diplomas.

Mount Carmel College of Nursing's SDAP is designed for individuals who have earned a baccalaureate degree or higher and would like to pursue a career in nursing. Students who complete the SDAP finish 13 full-time months of 40-hour weeks to complete a Bachelor of Science in Nursing (BSN). The program provides graduates the qualifications to take the licensing exam to become a Registered Nurse (RN.)

"This SDAP class has contributed over 1,200 hours of community service to under-served populations" said **Tanika Cherry, MSN/ED, RN-BC**, SDAP Coordinator.

"After plowing through for 13 months, graduates can expect to enter into a profession of service — one where they have the opportunity to make a difference in the lives of the patients and family members they care for."

At the ceremony, held in the MSB Auditorium, the *Lamp Award* was given to **Amanda Fee**; the *Inspiration Award* to **Tracy Matheny**; and the *Clinical Excellence Award* to **Jeremy Kojis**. The *SDAP Alumni Caring Leadership Award* and a \$500 scholarship were presented by the previous classes of SDAP alumni to **Margaret Hueckel**. The *SDAP Faculty Award* was given to **Brigit Duggan**.

"We are proud of the students," Cherry said, "and want to thank the MCCN community, faculty and staff for assisting 62 additional students realize their dreams."

Admissions Office Meets Students Where They Are

The lifeblood of a college is its students and a successful school thrives when it attracts good individuals and holds onto them.

At Mount Carmel College of Nursing, **Kim Campbell, MEd**, is responsible for getting those students in the door. She is the director of admissions and recruitment. While some things have changed since she began in the position in December 2006, the foundation remains the same.

"Nursing is just as popular as ever," Campbell said earlier this winter.

"Even being a single-purpose institution, I never feel like we have to scramble to get good students."

Most of the student contacts she and new admissions counselor **Julie Haley** make are within a nine-county area throughout Central Ohio. They visit dozens of high schools, attend college fairs and host open houses on campus. More than 50 prospective nurses attended such an open house in early February and another 100 were scheduled to visit mid-month.

Some things have changed, of course. Everything was done on paper seven years ago, Campbell recalled, and now the vast majority of applications are submitted online. Plenty of information also is exchanged via social media and even texting, she said, though she added with a chuckle: "I do not tweet!"

Even that could be different someday, as it remains so critical to reach students where they are in order to share Mount Carmel's story and attract the best candidates. "How students communicate is really important," Campbell said.

"When I go to fairs now, I see a lot of tablets. But still there's something to be said for looking through materials, and meeting face to face."

That reality was proven again this winter, when a student from northwest Ohio visited campus. She already had been accepted into Mount Carmel, but when her mother had some questions, they made the two-hour drive here through some wintry weather in order to see the campus and get a feel for the neighborhood. It was a personal visit that Campbell welcomed.

ATI Comprehensive Review for NCLEX Preparation

Students graduating from the traditional pre-licensure nursing program are required to attend an ATI Comprehensive Review for NCLEX Preparation. Students on track to graduate from the traditional pre-licensure program are assessed a \$300 senior year fee that enrolls them in the ATI NCLEX Review arranged by the College.

The onsite review is scheduled for May 13-15 (8 a.m. – 4:30 p.m. in the College Gym) for May and July graduates. The format consists of a three-day comprehensive in-class review.

October, December and March graduates are offered an onsite review session if there are a minimum of 25 students in attendance. If there are fewer than 25 students, graduates will enroll in the comprehensive review in a self-paced online format with an individually assigned ATI course instructor. Second Degree Accelerated students will receive information from the Program Coordinator about the ATI review session.

Are You Taking a Course Elsewhere? Past Deadline!

Any student taking a class at one of our affiliated institutions (Columbus State Community College or The Ohio State University) is required to submit a copy of his/her semester course schedule to the MCCN Records and Registration Office (Marian Hall, Room 2C01). **The deadline for submitting Spring Semester schedules was Friday, January 11.**

Students must also notify MCCN Records and Registration when they drop or withdraw from an affiliated course. We have found that students are sometimes negligent with this required notification to MCCN. Remember ... you must keep MCCN updated on your affiliated status!

Financial aid awards are based on total registered credit hours. Delinquent students may find themselves at less than full-time hours for financial aid calculation.

IF YOU ARE CURRENTLY TAKING AN AFFILIATED COURSE OR HAVE WITHDRAWN FROM AN AFFILIATED COURSE AND HAVE NOT ALREADY NOTIFIED RECORDS AND REGISTRATION, PLEASE DO SO IMMEDIATELY.

Students at Ohio University Lancaster

Students enrolled as freshmen in the MCCN-FMC program and taking classes at Ohio University Lancaster (OU-L) are also required to submit a copy of their semester course schedules to the MCCN Records and Registration Office (Marian Hall, Room 2C01). **The deadline for Spring Semester schedules was Friday, January 11.**

FMC program students must also notify MCCN Records and Registration when they drop or withdraw from an affiliated course. We have found that students are sometimes negligent with this required notification to MCCN. Remember... you must keep MCCN updated on your affiliated status!

According to Campbell, MCCN strives for a freshman class of about 140 students. To achieve that, nearly 500 applications will be received and reviewed between later fall and April 1. While there are some challenges to increase the amount of applications from minority populations and men, the overall numbers remain easy to reach every year.

"That's because one of the things we have going for us is we produce a great product," Campbell said. "We have been around for a long time and we're a direct-entry program, so students don't have to jump through lots of hoops."

Mount Carmel continues to achieve those numbers despite the competition from other programs such as those offered at Ohio State University, Capital University, Ohio University and others. One reason is the administration's commitment to continuously look at ways to reach students in an evolving world, from online courses to the Second-Degree Accelerated Program to the new Mount Carmel Clinical Skills and Simulation Center.

Among the many other characteristics of MCCN that help it draw great students every year are its location in the growing and vibrant city of Columbus, the presence of its own hospital next door, and the campus apartments.

Part of Campbell's challenge is making sure prospective students understand the academic rigor of the Mount Carmel program, and also the financial realities. "We don't want to sugarcoat things," she said, when it comes to the challenging classroom expectations. Students looking at MCCN must understand they need a college-prep background in order to make the transition into Mount Carmel more smoothly.

Campbell's goal also is to help prospective students and their families understand the financial side of the equation, and do what she can to help "eliminate barriers."

"They really need to understand the financial piece," she said. "It's not just about getting in, but 'How can I afford it?'"

Campbell's background as a financial aid officer at Bowling Green State University, and then more recently an administrator with the I Know I Can college-funding program in Columbus City Schools, provides her a strong foundation when having these conversations with families.

When everything clicks into place, it creates the right situation in which "People get here and know they want to stay," she said.

By signing up for our Mount Carmel Communications Alert System you can be alerted and informed in times of crisis, disaster and weather situations.

Faculty, staff and students may self-register for the system by using an on-site MCCN computer. Launch Internet Explorer and enter URL <http://mccnalert.mccn.int> and simply follow the prompts. Be sure to do the self-test that is part of the self-register process to confirm that the registration has taken place.

The alert system messages are TEXT ONLY and can be sent to cell phones, pagers, personal computers or other electronic message devices. There are no limits to the number of devices that can be listed.

You must register in order to be contacted and check the box to agree to assume any charges for alert system messages. Once registered you must update any changes to listed devices, such as new phone numbers.

Civility and Mutual Respect Are Needed, STAT!

(The following information was provided by the Mutual Respect Committee, Mount Carmel College of Nursing)

Bullying, shaming, distorting, gossiping, silencing, betraying, ignoring, and devaluing are just some of the words used when describing uncivil behavior.

It can take place anywhere; home, school, work, the mall or sporting events. It can be performed by anyone: parents, children, faculty, employees, supervisors, students, family and friends. It can be conscious and purposeful or unconscious and unintended. Incivility can cover the spectrum from a thoughtless word or gesture to acts of violence.

Why does it occur? Dr. Carl (n.d.) describes its causes as running the continuum from a response to stress to a feeling of entitlement. According to recent literature, incivility's presence in nursing and education is occurring at an alarming rate. Its presence is easy to find. The solution for ending it is much more elusive.

Perhaps the most profound description of incivility is that of "joy-stealing" (Heinrich, 2006). Certainly anyone who has been the recipient of uncivil behavior can attest to how it can diminish the human spirit.

But what can be done? The answer to that question is as expansive as the root causes. It can be as simple as bringing it to the perpetrator's attention. Perhaps the individual is not aware of the harm that was caused by a hasty remark or facial expression born from stress or frustration.

The answer must also range to an organizational posture of "zero tolerance" for such behavior. Mount Carmel College of Nursing has such a policy as outlined in the College Handbook's Code of Conduct. The existence of such a document invites discussion and collaboration. Acting on this policy takes courage and education.

A review of nursing literature revealed an online article and continuing education program from the North Carolina Board of Nursing, written by Crystal Tillman Harris, RN, MSN, CPNP. This article is a brief, yet substantive review of the problem as it affects all nurses...students, faculty and practitioners alike. It also offers viable recommendations for action by individuals and organizations. To read the article, type in the following website into your browser: **www.tinyurl.com/befoefu**.

Take time for education and reflection. Decide how to be part of the solution.

Construction Update

Senior Project Manager **Brian Teske** reported to Mount Carmel College of Nursing staff mid-February that the window replacement project was proceeding on schedule and remained on target for March 1 completion.

The project, by Quandt Construction Group Inc., involved demolition and installation of all windows at Marian Hall, installation of new sills and external flashing, and touchup painting and cleanup.

As the window work comes to completion, two other major upgrades are in the works for the aging facility. According to Teske, the building was reviewed for air-conditioning several times and drawings should be finished by the end of the month so AC work can begin on or about April 1.

Also, he wrote in an email, "Elevator design is under way with parts being ordered. We should have a confirmation on start time by the end of the month."

Teske is senior project manager, construction & facilities, for the Mount Carmel Health System.

Withdrawal Policy Reminder

Please be aware of the MCCN course withdrawal policy. For the purposes of this policy, there are two types of courses: non-nursing courses and nursing courses. Nursing courses include all courses with a prefix of NURS (with the exception of nursing seminars). Non-nursing courses include all other courses taken in the academic program (including nursing seminars).

- After the course start date, a student must first notify the course instructor and obtain his/her signature **prior to submitting an Add/Drop Form** to the Office of Records and Registration. Submission of the form is required for official withdrawal from a course.
- Non-attendance in a course after the withdrawal deadline is considered being absent from the course. Failure to submit a faculty-signed *Add/Drop Form* will result in a grade being assigned at the conclusion of the course. All course withdrawals are subject to the "Refund Policy" section of the *Student Handbook*.
- A student may withdraw from any course by the end of week 1 and the course will not appear on the transcript.
- A student may withdraw, without academic penalty, from a 16-week semester course by the end of week 12 of the course. A Grade of "W" will be posted to the student's academic transcript.
- A student may withdraw, without academic penalty, from an 8-week term course by the end of week 6 of the course. A grade of "W" will be posted to the student's academic transcript.
- A student may not withdraw from any course after week 12 of a 16-week semester course or week 6 of an 8-week term course.
- Summer courses operating on a modified schedule will follow deadlines equivalent to the proportional requirements stated above.
- A student may withdraw from only one nursing course during the program of study.
- A student may withdraw from a total of two different non-nursing courses during the program of study.
- A student who is retaking a course from which he/she has previously withdrawn may not withdraw from that course a second time; a course grade will be assigned at the conclusion of the retake.
- Withdrawing from a course does not force the student to also withdraw from a co-requisite course.

Banquet Brings Certain Lessons to Life

Mount Carmel students were scheduled to get a taste of hunger February 20, when the College of Nursing hosted an Oxfam Hunger Banquet.

Colleen Cipriani, Director of Student Life, was hoping to accomplish at least a couple of things when she scheduled the hunger-awareness activity. First, she was looking to get a lot of students together in a non-academic setting — which has been an uphill battle in a world of uber-busy students who often meet their social needs via social media outlets. Mission accomplished, as more than 70 students signed up for the lunchtime banquet.

Second, Cipriani hoped the experience would open students' eyes concerning the issues of hunger and poverty.

"It's a human rights issue," she said. "Everyone has a right to eat ... we hope to get students thinking about the disparities."

The premise is actually simple. Using a formula that matches the seats at the Oxfam banquet with global percentages of people living in hunger, only about eight people will get a full meal. Another 20 or so "middle wealth" people will get a moderate meal, sitting at the table with the "wealthy," while the vast majority of students will be asked to sit on the floor and dine on a bowl of rice.

Cipriani did say that no one would leave the event hungry, at least for food. She does hope they will hunger for more solutions to the problems of caring for people's most basic needs.

"We're teaching the nurses how to care for the 'whole person,' " at Mount Carmel, she said.

"We want them to be able to have more empathy ... to take away the notion that so many people are not in poverty because they are lazy. Give them an education and resources and they won't be in poverty."

The program typically takes 2-3 hours, but Cipriani was hoping to condense it to about 60 minutes in order to respect students' successes.

Community Service

Social Responsibility is one of the "Core Values" contained in the mission of Mount Carmel College of Nursing. In accordance with the College's *Mission and Catholic Identity*, the Community Service requirement for nursing students includes the application of one's skills and time to meet identified community needs of vulnerable and at-risk populations (e.g., children, elderly, homeless, poor and underserved, and organizations that support these populations).

This activity leads to learning and development through active participation in thoughtfully organized service that:

- is conducted in and meets the needs of the community
- involves reflection and analysis of the experience
- promotes the development of leadership skills, citizen skills, and social responsibility

Pre-licensure students are required to complete 20 clock hours of community service **prior to the beginning of the last semester of enrollment** (RNs enrolled in the BSN Completion Program and SDAP students must satisfactorily complete 10 clock hours).

Pre-licensure students who do not meet the deadline will be required to complete an additional 10 clock hours (for a total of 30 hours) in order to meet the graduation requirement. RN-BSN and SDAP students who do not meet the deadline will be required to complete an additional 5 clock hours (for a total of 15 hours) in order to meet the graduation requirement.

Any student who does not meet the requirement by the policy deadline may participate in Commencement activities, but will not receive a diploma or be eligible to take the NCLEX-RN licensing exam until this requirement is met.

Notes from Alyncia:

Registration is coming soon — check Carmelink, the Business Office Tab, for your balance.

Automation is the key: The financial aid office is putting applications online. Look forward to the Book Grant application and campus work program applications to be available soon.

Work Study Positions: If you will be enrolled in classes this summer and would like to work, please complete the Work Study Application online. Remember you must be enrolled for a minimum of 6 credit hours to work in the campus work program. Likewise, we are accepting applications for the 2013-2014 academic year (fall and spring).

2013-2014 Academic Year: Financial aid for the 2013-2014 academic year will be based on your 2012 tax return. This academic year covers — summer 2013, fall 2013 and spring 2014. If you are planning on taking classes during any of those terms, please complete your FAFSA as soon as you complete your 2012 tax return.

Please note, if you completed a FAFSA for the 2012-2013 academic year you will receive a FAFSA renewal reminder from the Department of Education. MCCN will not send individual reminders.

IRS Data Retrieval: This is the 2nd year for you and your parents to utilize the IRS Data Retrieval Tool to upload your tax information. It is my understanding that by doing this you will reduce our opportunity for being selected for verification.

Verification: Currently 30-40% of all of our students are selected for verification. This is a randomized process that historically required you and or your parents to submit a copy of your 2012 tax return transcript.

As in prior years, financial aid will be pending the completion of the verification process. Reduce your risk for selection and utilize the IRS tax upload process.

2013-2014 FAFSA: Plan early to complete your 2013-2014 FAFSA. In order to complete the FAFSA you will need the following:

- ✓ 2012 tax return for you the student, your parents if you are a dependent or your spouse if you are married.
- ✓ Your individual PIN number.
- ✓ 15 minutes to complete the online application at www.fafsa.ed.gov.

2013-2014 Award Letters: We will begin processing 2013-2014 award letters March 15th.

Award letters will be generated on a first come first serve basis. Please allow MCCN 2-3 weeks to process your award letters after the FAFSA has been received. Missing information or the need for additional actions will delay the processing of your award letter.

Following is an example of the message you will receive, if your FAFSA has been processed successfully.

Dear John,

Congratulations, your FAFSA has been processed successfully.

What Happens Next

- Your FAFSA information was sent to the school(s) on your FAFSA and they will contact you if they need additional information.
- Your school(s) will use your FAFSA information to determine what aid you may be eligible to receive.
- Contact your school(s) with any questions about your financial aid package.

Your Student Aid Report

Your Student Aid Report (SAR), which contains the information you submitted over the FAFSA, is now available online at the link below. Your school(s) will use the information on your SAR to calculate the amount of federal student aid you are eligible to receive.

2013-2014 Scholarship Process: Each year MCCN provides more than \$300,000 worth of scholarships. The donors are excited about investing in the lives of our students and we are most appreciative of their commitment to helping others pursue their dreams as a nurse.

This year all applications will be completed online. The financial aid office is working with IT to automate the process. Please look forward to forthcoming information regarding when the application process will begin.

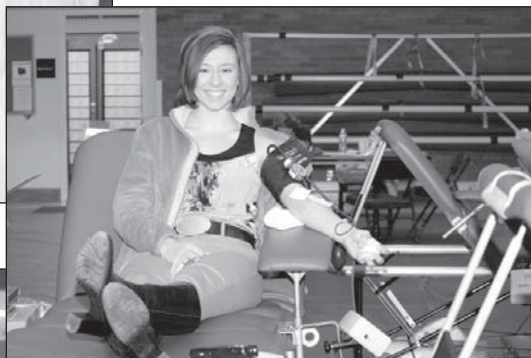

Stay tuned to CARMELink for updates regarding key information that graduating students need to know before May Commencement. Check this update for important deadlines and suggestions to keep your path to graduation on track.

- ▶ If you want to assure you are on track to complete all degree requirements, request a degree audit. Pre-licensure students contact Records & Registration; RN-BSN students contact **Tara Spalla** (tspalla@mccn.edu); Master's students contact **Kathy Walters** (kwalters@mccn.edu).
- ▶ Resolve any holds on your student record (business office balance, library materials, financial aid exit counseling) that will prevent you from receiving your diploma and obtaining a transcript.
- ▶ If not already submitted, complete your Community or Professional Service Program requirement and submit documentation forms to Colleen Cipriani (main campus, Pre-licensure program), **Deidre Smith** (Fairfield Medical Center program), **Therese Snively** (RN-BSN Completion program), or **Kathy Walters** (Master's program).
- ▶ Order graduation announcements and thank you notes (optional) at www.jostens.com (normal shipping time is 2 weeks).
- ▶ Order your cap/gown no later than **April 4, 2013**. Orders are placed online at www.jostens.com. Contact Records & Registration with questions (614-234-3870).
 - Try on your cap and gown when it arrives.
 - Remove wrinkles according to instructions provided and hang up the gown until Commencement.
 - Appropriate dress under the gown at Commencement is professional business attire (no flip-flops or sneakers and no "decorated" caps).
- ▶ If you wish to have your graduation announcement sent to news publications, respond by April 15 via the online form posted to CARMELink. A reminder, and a link to the form, will be sent to students at a later date.
- ▶ Undergraduate traditional program students — register to take the ATI Predictor and Critical Thinking Assessment coming up soon! Students will be notified via email how to sign up for a date and time.
- ▶ **Complete the BSN or MS Graduation Exit Survey.** Students completing all requirements by the end of Spring Semester and receiving diplomas on May 11 will receive email notification the week of March 25 with a link to the appropriate survey.
 - **Caution:** Do not confuse the notification email about the **Graduation Exit Survey** with the regular notifications about **Course and Faculty Evaluations** you are asked to complete at the end of each course.
- ▶ Prepare for graduation events:
 - **Graduation Celebration Luncheon** (Berwick Manor Restaurant) and mandatory **Pinning/Recognition and Commencement rehearsal** (First Church of God), Thursday, May 10, Noon.
 - **Pinning & Recognition Ceremony.** Friday, May 10, 7:00 p.m., First Church of God (students arrive by 6:00 p.m.).
 - **Commencement**, Saturday, May 11, 1:00 p.m., First Church of God (students arrive by Noon).
 - Additional details to follow at a later date.
- ▶ Each graduating student will be allotted five tickets for seating at Commencement in the main auditorium.
 - For students who responded to the ticket survey conducted in January, additional tickets will be available for guests to view the ceremony remotely in an adjacent auditorium.
 - Tickets for the two locations will be distinctly different; guests will be admitted according to which ticket they have. There is no charge for Commencement tickets.
 - All guests older than the age of 1 year are required to have a ticket.
 - Tickets will be available for pick-up beginning March 25 in the Records & Registration Office (Rm 201, Marian Hall, 9:00 a.m. – Noon and 1:30 p.m. – 4:30 p.m., Monday through Friday).
 - No tickets are required for the Pinning/Recognition Ceremony.
- ▶ **Pre-licensure students:** Plan to attend the ATI Comprehensive Review for NCLEX Preparation, May 13-15, 8:00 a.m. – 4:30 p.m. (College Gym).
